SOLVEO ENERGIES - SUCCESSFUL BIDDER IN THE 2ND CFD AUCTION IN ROMANIA

Solveo International, a subsidiary of Solveo Energies, France, has through its SPV ACK SRL, been awarded a Contract for Difference (CfD) by the Romanian Ministry of Energy in the country's second CfD auction as announced on the 12th of August, 2025.

The contract is for a 15-year term and attributed to Solveo's Sticlaria project, a **38.4 MW wind farm** located in the laşi county in the northeast part of Romania. The project is expected to break ground in **Q2 2026**

Once operational, the wind farm with 6 wind turbines will generate around 105 GWh of clean electricity per year, equivalent to powering 58,000 Romanian households and avoiding \approx 28,600 tons of CO₂ emissions annually.

Olga Constriiciuc, Country Manager, Solveo Romania, said "This remarkable achievement would not have been possible without the dedication, professionalism, and hard work of the Solveo team, as well as the invaluable contribution of our subcontractors and partners, who provided unconditional support throughout the entire process.

We also extend our sincere appreciation to the Romanian Authorities for successfully organizing the second CfD auction and for establishing the robust legal and regulatory framework that enabled this landmark initiative.

The awarding of a Contract for Difference (CfD) to our project, CEE Sticlaria Wind Farm, represents not only a major milestone for Solveo in Romania, but also a significant step forward in supporting the country's clean energy transition.
